## HIGHLIGHTS

➤ **Current cash on hand of A\$3.18m and no debt.**

The Company progressed the structural wind down of the proposed Serenje Manganese Project in Zambia.

Termination Agreements to divest the Company's interest in the majority of the tenements held have been executed.

The process is well underway to dispose of a number of the holding companies through which these tenements were held.

### *Prospecting Licence 18956-HQ-LPL*

During the quarter, the Company received the consent from the Chief of the traditional local authority to the grant of Prospecting Licence 18956-HQ-LPL. A survey and demarcation exercise was undertaken and pegging was completed for the licence area. An Environmental Project Brief was completed to be submitted to the Zambia Environmental Management Agency for approval.

These are all requirements of the conditions of grant of the licence by the Ministry of Mines and Minerals Development, Zambia.
